



Membership Terms & Conditions 2019

1. 2019 Membership packages are valid for one year from the date of purchase.
2. Membership packages include unlimited access to the rides during the operating season. Minimum of 90 days per calendar year, please see our website for opening times.
3. For avoidance of doubt, Membership does not cover entrance to ticketed events held at Dreamland.
4. For avoidance of doubt, Membership discounts on food, drinks and retail do not cover all products. Only selected products shall be discounted.
5. Details of ticketed events will be available on the Dreamland website and the Amusement Park may be closed to the general public on these days. Please check the website for opening dates and times.
6. Membership cards are non-transferable and are strictly for the use of the named person only. Proof of identification may be requested. You must not allow anyone else to use your card, membership wristbands or Membership number. If you allow, or intend to allow, your membership benefits to be used by any other person, your Membership will be cancelled without refund of any Membership Fees or Activation and/or Joining Fees; no further or future applications for Membership will be accepted for a minimum of 12 months. Future eligibility for Membership will be reviewed at least annually upon request.
7. The management reserve the right to withdraw the Membership card(s) should they feel they are being misused or if any person engages in any form of threatening or abusive behaviour or is perceived to present a risk to any park user, staff member or third party.
8. Membership benefits cannot be re-sold, exchanged or refunded. This includes intent to re-sell any membership benefit. To alter or deface the Membership card in any way will render it void.
9. If you have been in the park and decide on the day that you wish to become a Member, Dreamland will refund you the price of one wristband per person and take it off the cost of your Membership package. A receipt must be shown to obtain your refund.
10. The park will be closed at certain times throughout the year. Please check the Dreamland website before visiting.

11. Rides are subject to availability, may be closed for maintenance or may be shut due to inclement weather conditions. Please check the Dreamland website before visiting.
12. Dreamland will make every effort to ensure that rides and attractions are operating when the park is open to the public. Dreamland cannot commit to operating all advertised rides and attractions every day and will endeavour to publicise any changes to the line-up as soon as reasonably possible.
13. Dreamland reserves the right to amend ticket and Membership prices at any time without prior notification to ticket holders, guests and Members.
14. Dreamland reserves the right to change the operating hours of the park at any time at the discretion of management. Please check the Dreamland website before visiting.
15. A child or children under the age of 14 must be accompanied by an adult aged 16 years or over or will be refused entry to the park. Once inside the park the child(ren) must always remain under the supervision of an adult. In the interests of safety and security, Dreamland reserves the right, in its absolute discretion to change the age restrictions referred to in this condition, without any prior notification.
16. Dreamland Members may skate for free in the Roller Room. However, please note, this is done on a first come first served basis due to capacity. Please see below for the Roller Rink's full terms and conditions with regards to the safe use of the Roller Rink.
17. If your Dreamland Membership card is lost or stolen please return to Dreamland Margate as soon as possible so we can cancel and issue you a replacement card. Please note, there is a small administrative charge for replacement cards. Please be aware you will not be reimbursed for any additional charges you have incurred whilst you have not had your card (i.e. car parking and membership discounts).
